GENERAL RULES

1. TDA Rules apply in all PokerAtlas Tour events.

2. Buy-in is \$330 (Prize Pool) + \$70 (Admin).

3. Unlimited re-entries available through the close of registration (Start of level 9) for \$400.

 Players who bag multiple flights will have their smallest bag removed and receive a min-cash for that bag.

5. Players are required to have a Genting Rewards Card.

6. 12.5% of the Day 1 field will be ITM. 8% of the field will advance to Day 2 and return Sunday, March 2 at 1:00 PM.

7. Responsible Gaming: Resorts World Las Vegas adheres to the American Gaming Association's Code of Conduct for Responsible Gaming. Resources are available to patrons explaining the probabilities of winning or losing. ADDITIONAL RULES AND REGULATIONS

1. Tournament entry fees and all re-entries must be paid with cash or Resorts World casino chips; no other forms of payment will be accepted.

2. The ante amount will be posted by the big blind only. In the event that the player in the big blind has less than the required amount to post both the big blind and the ante, the big blind will be posted first. The ante will then be posted with any remaining tournament chips.

3. Tournament staff reserves the right to reassign the seat of a registered player who has not arrived to claim their seat. Players may be placed on the alternate list until they check in with the tournament staff.

4. At the conclusion of the registration period, all paid entries (including alternates) who have yet to be seated will be assigned a seat and their tournament chips will be put into play even if they are not present.

5. All alternates (present or not) will have their tournament chips put in play in numerical order when the tournament has alternates on standby.

6. Tables will be played 9 handed, unless mandated otherwise, the final table will be played 9 handed.

7. IRS Compliance requires a valid government issued ID and a social security number. Nonresident aliens are subject to 30% US Tax withholding. ITIN's are required for Treaty Country exemptions. All players winning \$5,000 or greater (net of Tournament Entry Fee) will be issued a W-2G tax form.

8. Resorts World Poker and standard TDA rules apply.

9. Players and guests must be at least 21 years of age.

10. Players and guests will be required to adhere to all applicable Resorts World Las Vegas policies.

11. Resorts World Las Vegas reserves the right to refuse entry to, or disqualify, any individual at any time before, during, or after the Tournament, for any reason in Resorts World Las Vegas' sole discretion.

12. Players who are unable to participate or have been disqualified, are not entitled to any refunds or payouts.
